no indication that the plaintiffs have been able to locate any other similarly-situated individual or entity that has already been granted an export license to import [the SKS rifles at issue]... the plaintiffs have not provided any evidence of actual or prospective economic harm to them or other similarly situated persons or entities.... The Court therefore finds that the plaintiffs have not established the existence of a genuine issue of material fact. Pls.'

Opp'n, Ex. 12 (Final Agency Decision) at 5-7. As indicated above, this court need not evaluate the efficacy of the agency's reasoning if it correctly applied the law. See *Marshall County, Ala.*, 207 F.3d at 1356. Therefore, the court does not consider the issues of whether (1) there is a relevant competitor who could have imported these types of weapons from the Czech Republic, (2) the plaintiffs have established injury, or (3) there are any similarly situated persons or entities who have been harmed. The court grants summary judgment for the defendants on this issue.

V. CONCLUSION Accordingly, the court grants the defendants' motions for summary judgment. An order consistent with this Memorandum Opinion is separately and contemporaneously issued this 6th day of December, 2007.

NOTES [1] In the defendant's motion, the GOC of the Czech Republic is referred to as the "Czech Republic." However, the official title of the GOC of the Czech Republic is "State Office for Arms Export Controls," or "State Office," and will be used herein. [2] The plaintiffs also claim that they were denied due process when the GOC determined that it was in the national interest to extend the deadline for the AK-47 application to 9 November 1998. Pls.' Opp'n at 26-30. The court finds that it need not address this issue because it has already found that the GOC decision to deny the plaintiffs' application was in the national interest and in the public interest. [3] The SKS is a Russian-made weapon that is more commonly known as a "Kalashnikov." The Czech National Police Force, or "NBP," purchased nine Kalashnikovs from the Russian military. In 1996, the NBP placed
